Statement of Probable Cause / Narrative

Date of Crime: 06-17-2025 to 06-18-2025
Time of Crime: 08:40 to 16:00

Assignment

On June 16th, 2025, I, Detective [REDACTED] of the Port St Lucie Police Department, assigned to the Internet Crimes Against Children (ICAC) South Florida Task Force was utilizing the messaging application Kik while working in an undercover capacity. For this assignment, my profile listed my screen/username as “gurlmom2_2”. My picture showed a photo of the moon, and I was in a group chat called “parents who play”. This group chat is about sexual abuse of children.

ICAC Task Force

The City of Port St. Lucie is a part of the South Florida Internet Crimes Against Child Task Force. The Task Force receives Cyber Tips from National Center for Missing & Exploited Children (NCMEC). The National Center for Missing & Exploited Children is a private, non-profit organization created to serve as a Clearinghouse and resource center to assist in missing and sexually exploited child issues. The Program was created to help State and local law enforcement agencies enhance their investigative response to offenders who use the Internet, online communication systems, or other computer technology to sexually exploit children. This “help” includes forensic and investigative assistance, referral of investigative leads concerning online child sexual exploitation, training and technical assistance, victim services, and community education.

- i. The Task Force is charged with performing the following activities and duties:
Disrupting computer facilitated crime within the area of the City of Port St. Lucie, especially Internet child predation, the possession and distribution of child sexual abuse material and luring, by identifying, investigating, arresting and prosecuting those individuals responsible for violating the criminal statutes involving possession or transmission of CSAM, and prohibited computer usage involving seduce, solicit, lure, or entice or attempt to seduce, solicit, lure, or entice a child or parent or legal guardian of a child to otherwise engage in any sexual conduct.

- ii. Gathering and reporting intelligence data relating to computer crimes; and
- iii. Conducting online undercover operations and physical surveillance activities where appropriate, as well as other, traditional, methods of investigation, to insure the effective prosecution of those charged with violating the law.

KIK

Kik is a free mobile messaging app that allows users to connect with friends and strangers through chat, using usernames instead of phone numbers. It offers features like one-on-one and group chats, sharing of media (pictures, videos, GIFs), and the ability to explore and interact with public groups.

Investigation

On June 16th, 2025, I received a message from a user with the display name: machteleven and username: machteleven, which stated: “Hey girl mom!”. On June 17th I responded, and the following chat messages proceeded:

It should be noted for clarity of this report, the subject’s Kik username, machteleven, will be used to address him throughout this report.

Gurlmom2_2: Hey what’s up
 machteleven: Hey hey! I’m Jason, 45, Savannah GA.
 Gurlmom2_2: 36 F st lucie Fla
 machteleven: Nice nice
 machteleven: And how old are your girls
 Gurlmom2_2: 5 and 9. Wbu
 machteleven: Unfortunately I am not a father
 machteleven: Are you a bad mom
 Gurlmom2_2: Bad mom as in what?
 machteleven: As in like....open minded let’s say
 machteleven: Or any other bad way you can think of
 Gurlmom2_2: Open minded Yes
 machteleven: Cool cool
 Gurlmom2_2: What are you into
 machteleven: Hopefully your girls haha

My chat communication continued with this user. I informed the Kik user machteleven about my two fictitious children: Sophia (5YOA) and Natalie (9YOA). Machteleven continued to inquire about the two female children, asking “Do you think they’d like to play with a cock” and if I would be ok with 5-year-old Sophia having a boyfriend. I responded by explaining that Sophia is a sweet girl and would make someone happy. Machteleven responded by telling me: “Sophia. Now of course I’d court her”, “Bring her gifts, pretend to be her dad”, and “Hopefully I could take Sophia out on a date, once we’re comfortable?”.

The following are excerpts from the chat which details how machteleven wants to spend an encounter with “Sophia”. I chatted with machteleven about the park, in which he responded that “People would just assume I’m her dad”.

machteleven: Now I'm sure you know that when a guy takes a girl out for a nice date, he expects to cum after Ward

gurlmom2_2: How can we make that happen

machteleven: Bring her back home and do something

machteleven: Or maybe in the back seat

gurlmom2_2: Both would work. But do you have window tints bc I do not

machteleven: I'd get them installed to protect Sophia's privacy

gurlmom2_2: What do you have in mind that you want her to do to make you cum

machteleven: Oh I think just stroking at first

machteleven: And I would just cum all over her clothes at first to get her used to it

gurlmom2_2: That would help me to start introducing her into this

gurlmom2_2: She is very playful and finds it to be a game

machteleven: aww

machteleven: Now eventually a bf and gf fall in love

I asked Machteleven, how do you know how to treat little girls? and "Do you have experience". He responded by telling me he does not [have experience], "But I've thought a lot about it". He then proceeded to tell me "I think Sophia and I will really hit it off", "In the morning helping her get ready for school", "She fell asleep with cum on her face again, have to wipe the stickiness off". Machteleven then proceeded to tell me he has been thinking about this for "years and years and years" but has never had the opportunity to carry this out. Machteleven then continued to express his desire to have Sophia wear his "cum" on her clothes and to smell like him when she goes to school. The following is a continuation and excerpts of the chat.

gurlmom2_2: What do you have in mind that you want to do first with Sophia

machteleven: I mean I think meeting her just pretend to be her dad probably

machteleven: And hopefully by the end of our first or second meeting, take her clothes off

machteleven: And certainly at least by our second meeting show her my cock and start explaining things

gurlmom2_2: Yes very slowly since she is 5 yrs old she will be curious

machteleven: Yes for sure. I mean I'll take your opinion too for sure, what are your thoughts?

gurlmom2_2: I feel good so far with your suggestions as long as you are careful with her

gurlmom2_2: And not too aggressive

machteleven: Yes of course

machteleven: You can slow me down at any point

gurlmom2_2: Ok perfect. Thank you for understanding

machteleven: Absolutely! I think you're a wonderful mom

machteleven: Will you be proud of her for making a guy cum that much?

gurlmom2_2: I definitely would. How do you want her to make you cum ?

machteleven: Well stroking makes sense at first

machteleven: Then when she's comfortable we'll move on to oral

gurlmom2_2: Ok that's good

gurlmom2_2: Good plan

machteleven: Thank you!

machteleven: And then eventually....
gurlmom2_2: Yes....
machteleven: Inside her
gurlmom2_2: She is a small girl you need to be careful
machteleven: Yes of course

Machteleven continued to speak with me about “Sophia” wearing a ring and stated “Hopefully she’ll be wearing a ring at home by then :)” which would be a great way to break the ice between them. Machteleven spoke to me about wanting to see “Sophia” wearing “a cum stained t-shirt”. I reminded machteleven again that “Sophia” is 5 years old and that she laughs at everything. In which he responded to this by telling me “I start thinking if I cum right in her beautiful face — and I mean just cover it totally — there’s a good chance she’d just giggle!!”. He then told me again: “You’re like the best mom ever”, in reference to me wanting “Sophia” to be happy with the sexual acts. The chat continued as follows:

gurlmom2_2: I’m all they got
gurlmom2_2: And thank you
machteleven: I want her to always have a goofy grin because she’s so so happy
machteleven: Hopefully you won’t be all Sophia has for long
gurlmom2_2: Hopefully [fingers crossed emoji] I don’t trust easily. But you seem kind
machteleven: How far do you think we’d get if I came down for a weekend
gurlmom2_2: I think it would depend on you and how she vibes with you. She is very sweet
machteleven: I wonder if it’s possible that she and I would share a bed the second night

machteleven: And I understand that you wouldn’t want me to take her out on a date the first weekend
machteleven: If I make a good impression and I’m invited back, I can hope for that
gurlmom2_2: Well I would need to ease you in, but depending on how it goes as well
machteleven: Yes of course
gurlmom2_2: But yes. A good impression is important
machteleven: Absolutely!
machteleven: Be an absolute gentleman
gurlmom2_2: Thank you

Machteleven proceeded to speak with me about wanting to become “platonic friends” with me if Sophia became his girlfriend. He asked me: “Is it weird to think that even though I’d have a romantic relationship with Sophia, that maybe we could also sort of co-parent her?”. We continued to speak about the dynamic of our friendship, which would allow me to spend more one-on-one time with “Natalie” while he was with “Sophia”. He then asked me: “If we are in a world where you trust me....if Sophia is on a date that ends with a handjob, a messy shirt, etc....that’s still being cared for right?”. I expressed that I want Sophia to be happy and I need to be comfortable with him. Machteleven asked “Do you think eventually Sophia could spend a whole weekend with me”, in which I responded by advising it would be a possibility, but it will be a process to get to that. The conversation continued as machteleven proceeded to explain to me that when he first initially meets Sophia, he would tell her she is cute and that he wants to be her dad. Once she is comfortable, he will start helping her take her clothes off. He then told me “If you’re comfortable, I’d like to go down on her and I’d like her to play with my cock”.

The conversation shifted to exchanging personal information about ourselves. Machteleven told me again his name is Jason, he lives near Savannah, Georgia where he has lived for 11 years, but originally from Virginia.

The conversation ended and picked up again the next day, June 18th. Machteleven told me that he “can’t get over thinking about her [Sophia] and my cum. I’m like focused.” The chat continued as follows:

machteleven: I have this hope — maybe unrealistic — that Sophia will just love it. And love cum specifically
gurlmom2_2: As long as you are careful with her
machteleven: Of course of course
machteleven: What would you be comfortable with? Specifically?
gurlmom2_2: As far as what?
machteleven: With cum
gurlmom2_2: What are your thoughts on how you want to cum?
machteleven: Stroking I guess I meant more like after I cum
machteleven: What if I want her to keep her messy shirt on
gurlmom2_2: As long as it is not overly obvious in Public
machteleven: Hehe it’s a little exciting to think about though lol
machteleven: But I understand
gurlmom2_2: lol
gurlmom2_2: Who would do the stroking?
machteleven: Eventually her but at first whatever you both are comfortable with
machteleven: Is that ok?
gurlmom2_2: Can I watch?
machteleven: I assumed you would be there the first time. I would love you to be there.
machteleven: You can praise her :)
machteleven: Look how pretty you are now Sophia!! Things like that
gurlmom2_2: [smile face emoji]
gurlmom2_2: That would make her feel comfortable for sure
machteleven: I think so too
gurlmom2_2: She trusts me very much
machteleven: You could really help like next time don’t you want it in your hair Sophia? Things like that
machteleven: Well she should you’re an amazing mom

The chat conversation continued in which Machteleven told me he is divorced after being married for 7 years. I told him I am not in a relationship and men only come and go out of my life. Machteleven responded by telling me “I wouldn’t come and go”. He then told me “Well I’d cum. All over Sophia’s nightie in the morning. Then go. To work. Then come. Home and hang out with all of you. I’d enjoy having dinner with you and appreciate that you haven’t let Sophia change her nightie”, “Work hard all day, then come home and relax”, “And Sophia would help me relax”.

As the conversation progressed, machteleven asked me “Should I pack like a weekend bag?”, he told me he feels he will fall for Sophia, in which I responded by telling him she is the sweetest 5 year old. The chat then progressed to machteleven’s ideas for Sophia.

machteleven: I have an idea to introduce her to the taste of cum but I don't know if you'd go for it
 gurlmom2_2: Oh. What is it
 machteleven: Well. How would you feel about having it like on her food or in a drink or something
 machteleven: Her clothes her hair her face her bedsheets
 machteleven: Her pillow
 gurlmom2_2: Yes. You would like that?
 machteleven: If by like you mean love then yes lol
 gurlmom2_2: lol
 gurlmom2_2: Yes that would answer the question then
 machteleven: Haha
 machteleven: This might sound stupid but I think that's actually like a super romantic way to start a relationship

The chat conversation continued in the topic of protecting the girl's safety and privacy. Machteleven told me "The beautiful intimate moments in the back seat are very private". The chat ended near this point, as machteleven stopped responding.

On July 2nd, 2025, Detective Jones conducted a forensic exam of my police department issued UC Apple iPhone. The following facts were conveyed to me from Detective Jones. A full file system extraction was completed using Gray Key. Gray Key identified the following unique identifiers of the device:

Gray Key extracted 17.85GB of data. Det. Jones loaded the file system extraction into Cellebrite Physical Analyzer and decoded the extraction. I did a keyword for machteleven and located numerous KIK messenger chats. I exported all of the chats linked to the username machteleven.

On June 17th I drafted and submitted a subpoena to the State Attorneys Office for the Kik account user information for machteleven.

On a later date, I received correspondence from Kik, who provided the following information:

- A friends list, which contained 9KB of data of various Kik users.
- IP log containing 13 KB of data.
- A content folder, which was empty
- Subscriber data, which provided email address: machtkcihdhshw@comcast.net and a list of IP and Port Numbers.

After reviewing this information, I drafted and submitted subpoenas to Comcast for the email address and to Verizon for the IP and Port number subscriber information. The IP address was confirmed to be Verizon through an open source – web-based search.

The following Verizon IP addresses were requested on the subpoena, which I located from the Kik Subpoena production.

I ran the IMEI online using imei.info and it indicated the IMEI is issued to an iPhone 15 Pro.

It should be noted that in reference to IP address 174.224.51.176 Port 2605 - 06/16/2025 15:10:50 UTC, Verizon was unable to identify the subscriber information for the phone number for this specific Natting IP address. Verizon reran the records for a longer time frame for the port number provided, however it could not be found in the address records.

The response from Verizon Legal also contained numerous documents that were requested in the subpoena that targeted the IP linked to the Kik account. Detective Jones assisted with the documents sent by Verizon. In the IPv4_Natting_Results_Case_25427651.xlsx Excel spreadsheet Verizon sent the requested IP V4 with port numbers that were resolved to Verizon User 313.510.8490. In the Excel spread sheet there were numerous sheets, each one contained the time, date, IP and port number issued to 313.510.8490. The following is a summary of the IP and port history:

Sheet 1 Line 59: indicated that IP 174.224.51.176 and port allocation was 3328 to 3359 from 06/15/2025 2009 hours till 06/17/2025 1041 hours

Sheet 4 Line 41: indicated that IP 174.224.51.176 and port allocation was 2720 to 2751 from 06/16/2025 1821 hours to 06/17/2025 0250 hours

Sheet 5 Line 42: indicated that IP 174.224.141.192 and port allocation 2880 to 2911 from 6/18/2025 1505 hours to 6/18/2025 2321 hours

Sheet 6 Line 46: indicated that IP 174.224.141.192 and port allocation 3040 to 3071 from 06/18/2025 1359 hours to 06/19/2025 0032 hours.

Based on the IP history and port allocation the only phone number on the Verizon network that had the IP and port combination captured by KIK was phone number 313.510.8490.

After reviewing this information, I completed a search using TLO for the phone number provided in the Verizon return [3135108490]. TLO provided search results for

Michigan Driver's License: M632887429394

I ran the provided drivers license through NLETS and located information for William John Murdoch. The address on file with his Michigan drivers license is 30180 Helmandale Dr. Franklin, MI 48025. Issue Date: 03-10-2023.

This information was forwarded and turned over to the Homeland Security Office in Fort Pierce for further follow-up.

On Wednesday July 23rd I learned William Murdoch and his wife were currently out of the country and scheduled to return to Detroit, MI (via direct flight) on Monday July 28th. It was also determined that the phone number used to book the flight tickets, was the same phone number provided by Verizon in subpoena production, linked to William Murdoch's Verizon account.

Also on this date, I spoke with Special Agent Alley, who is with Homeland Security Detroit to relay the above information. SA Alley assisted with this investigation and with putting a secondary security hold on William Murdoch at the Detroit airport Customs area.

Based on the information received from Verizon that the IP and Port numbers are linked to an Apple iPhone owned by William Murdoch, I drafted and submitted a Search Warrant and Search Warrant Application for William Murdoch's Apple iCloud account and Apple download history to the State Attorney's Office for their review and approval. Both documents were approved and taken to Judge Hendriks who signed them on July 25th. Also, on this date I uploaded the Search Warrant document to Apple via their Law Enforcement Portal.

On July 28th SA Alley followed up with me to advise he met with Murdoch at the airport upon his arrival back into the United States. SA Alley told me Murdoch denied using Kik messenger and requested an Attorney be present upon further questioning.

SA Alley advised he manually reviewed Murdoch's cell phone device that was in his possession. The Kik application was not located within the device. SA Alley did confirm the devices unique identifiers [IMEI, Serial Number] which did match the identifiers provided in the subpoena production by Verizon.

On a later date, I received the Search Warrant Production from Apple with the contents of Murdoch's iCloud account. Apple provided 204 GB of data. The data was provided to forensic examiner Det. Jones, who processed the data using Magnet Axiom. Once processed, the data was reviewed, and it was determined that Kik was downloaded to Murdochs device multiple times.

Det. Jones assisted with downloading and processing the data from Apple. Upon reviewing, Det. Jones relayed the following findings to me:

Apple provided a document labeled APL000001_APPLE CONFIDENTIAL.xlsx. In this document, numerous items were found linked to the investigation.

In the Apple Media Services Update Device (AMSUpdates_Devices) tab of the document it indicated that from 2024-07-28 11:39:14 hours (PDT) till 2025-06-16 08:09:40 (PDT) Kik Messaging & Chat App was updated or redownloaded eighty-five times linked Global Unique Identifier (GUID) 00008130-000A18423461001C.

In Excel Cell ID 1623 it indicated that the Kik messaging application was downloaded to GUID device 00008130-000A18423461001C on 2025-06-16 08:09:40 (PDT). It should be noted that the illicit conversation started with Detective Astrella on 06-16-25 11:20 (EST). Based on the time zone conversion Detective Astrella was messaged exactly eleven minutes after the Kik messaging application was downloaded to the phone. It also indicated that the version iOS of the device was iOS 18.5.

In the Apple Media Services Update Account (AMSUpdates_Account) tab of the document it indicated that from 2001-01-01 to 2025-06-18 the Kik Messaging & Chat App was downloaded or updated eight hundred and nineteen times. It should be noted that there were numerous GUIDs during this time frame.

In the GCRM_Devices tab it listed the following unique identifiers: Serial Number ML6Y44Q6W5, IMEI 352917262405953, IMEI 2 352917263750928.

In the Device Key Tab, I located GUID 00008130-000a18423461001c and it is issued to Apple serial number ML6Y44Q6W5.

In the 69236649_AccountDetails.xlsx it listed the account owner as: Apple ID williamjmurdoch@gmail.com WILLIAM MURDOCH, +13135108490

Det Jones relayed that based on the results of the Apple search warrant return it is apparent that Kik Messaging & Chat App was downloaded and/or updated to Apple serial number ML6Y44Q6W5 approximately eighty-five times specific to this device.

These documents were bookmarked as evidence in the Axiom report. A portable case was generated and logged as evidence.

On August 12th, I drafted and submitted a Search Warrant and Search Warrant Application for the Kik account for Kik username: machteleven to State Attorney's Office for their review and approval. Both documents were approved and taken to Judge Hendriks who signed them on August 13th. Also, on this date I uploaded the Search Warrant document to Kik via their Media Lab Law Enforcement Portal.

On August 14th I received the Search Warrant Production from Kik with the contents of machteleven's Kik account. Kik provided 1.75MB of data. The data was provided to forensic examiner Det. Jones who processed the data using Cellebrite.

Once processed, the data was reviewed. It was determined that the content of the messages exchanged between myself and Kik username: machteleven and the time stamps matched the messages on my UC iPhone that I used to communicate with Kik username: machteleven.

I also reviewed and noted that machteleven was communicating with numerous other unknown individuals, which involved sexual dialogue about children. Machteleven also discussed "saline abortions" and how "It stops the baby's heart and it causes contractions" at the gestational age of 37-38 weeks. The Machteleven then states once this is completed: "You can imagine the wonderful rest lol". He then asked, "Does it have any appeal".

Machteleven communicated with another Kik user in which he spoke to this person about her becoming pregnant, having a baby shower with family, which would proceed with a saline abortion and stated, "Seeing you deliver Lily after it's over...". The communication continued in which he spoke to this Kik user about intentionally drinking alcohol and using drugs during her pregnancy.

In summary, this investigation revealed the following:

- Based on the Online Undercover Chat Operation on the Kik messaging application while portraying myself as a mother of two daughters, ages 9 and 5 while engaging with subjects in a Kik group dedicated to sexual abuse of children.
- Kik user: machteleven began a chat with me, in which I received messages inquiring on the age of my UC persona's children and sexual desires towards children. User machteleven spoke about his sexual interests and desires to meet the 5-year-old daughter of my UC persona and how I would assist and facilitate this as her parent. Machteleven described in detail his sexual desires and how he would engage in sex activity with my 5-year-old daughter.

- A subpoena was submitted to Kik requesting account information for machteleven. Kik complied and provided IP addresses and Port numbers. Verizon was determined to be the issuer of the IP numbers.
- Based on the IP information in the KIK subpoena a subpoena was sent to Verizon for various IP and Port numbers. Verizon complied with and provided subscriber information linked to the IP and Port: William Murdoch, 30180 Helmandale Dr, Franklin, MI. Phone number: 3135108490. Verizon also provided unique device identifiers (IMEI, serial number) for an iPhone.
- I gathered further information from HSI on William Murdoch, in which it was learned that Murdoch was currently out of the country and will be returning to the United States on July 28th by flying directly into Detroit. SA Alley [HSI Detroit Office] met with Murdoch at the airport in Customs as he was returning. SA Alley previewed Murdoch's phone and determined the device identifiers (IMEI and serial number) matched what Verizon provided in subpoena production. Also, the iOS version matched what was in the Kik search production and Apple production, iOS 18.5. Kik was not found to be on Murdoch's phone, he also denied using Kik.
- I submitted a Search Warrant to Apple for Murdoch's iCloud account. Apple complied and provided the contents of the account. While reviewing it was determined that Kik was downloaded multiple times to the phone that was verified to be in Murdoch's possession by SA Alley.
- I also submitted a Search Warrant to Kik for username: machteleven. Kik complied and provided the contents of the account. Multiple communications were reviewed which depicted conversations involving sexual dialogue about children and causing birth defects by drinking alcohol and using drugs during pregnancy and doing saline abortions towards the end of the pregnancy (37-38 weeks). In the search warrant it also indicated the that machteleven account user had been using an Apple iPhone (BIND in production) and the iOS was 18.5.

Based on all the facts above, your affiant has reason to believe that William Murdoch used the Kik messaging on his iPhone 15 to engage in soliciting a parent to consent to the participation of sexual conduct involving a child.

I believe probable cause exists to charge William Murdoch with Prohibited Computer Usage - CERTAIN USES OF COMPUTER SERVICES OR DEVICES PROHIBITED pursuant to FSS 847.0135(3)(b). (1 count)

William Murdoch did use an electronic device to Solicit, lure, or entice, or attempt to solicit, lure, or entice a parent, legal guardian, or custodian of a child or a person believed to be a parent, legal guardian, or custodian of a child to consent to the participation of such child to engage in any sexual conduct.

I respectfully request a warrant for this charge.
